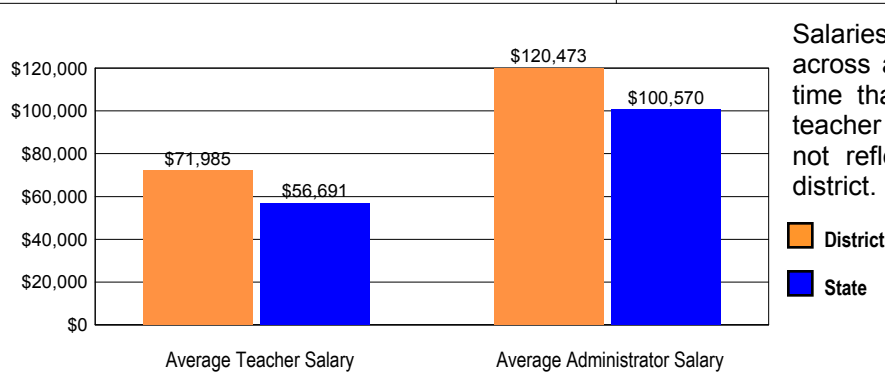

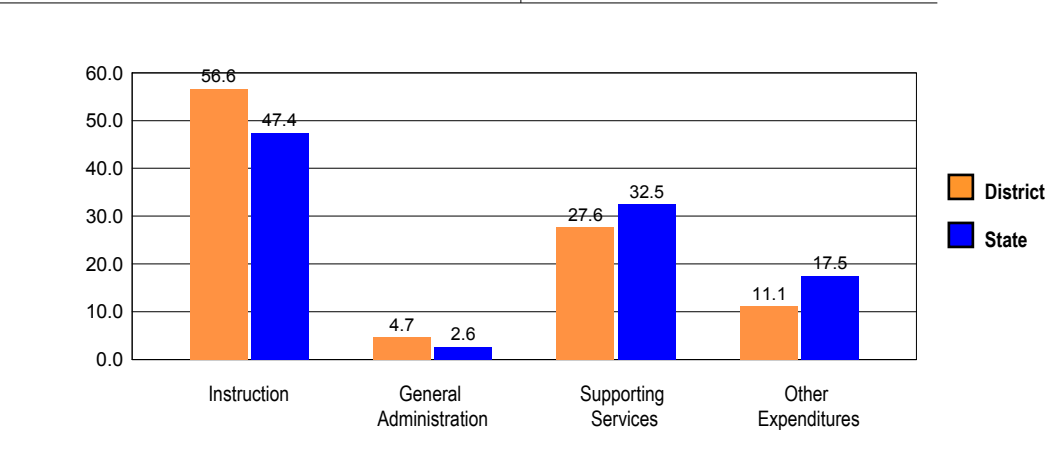
SCHOOL DISTRICT FINANCES

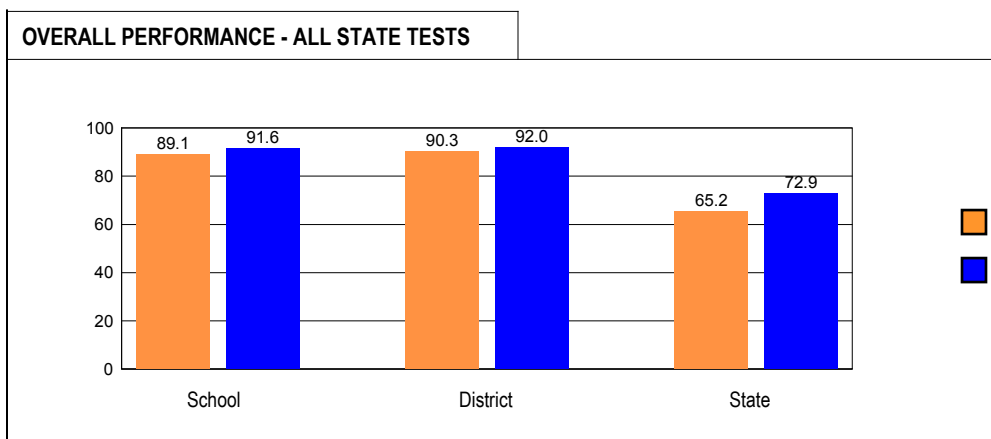

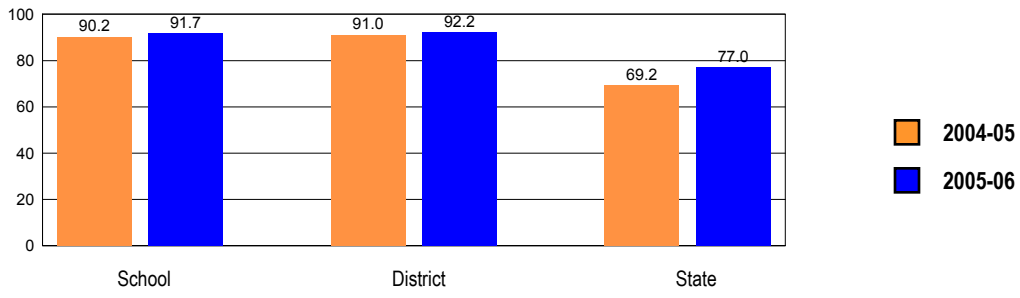
OVERALL STUDENT PERFORMANCE

Caution: Data for 2004-05 should not be compared to data for 2005-06 because substantial changes were made to the state test in 2005-06 when testing in reading and mathematics was expanded to include all grades from grade 3 through grade 8. In 2004-05, such testing was limited only to selected grades. Although there were no changes in high school testing, data in high school report cards at the state level (and also at the district level for unit districts) are not comparable between the two years because of changes in elementary school testing mentioned above.



OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

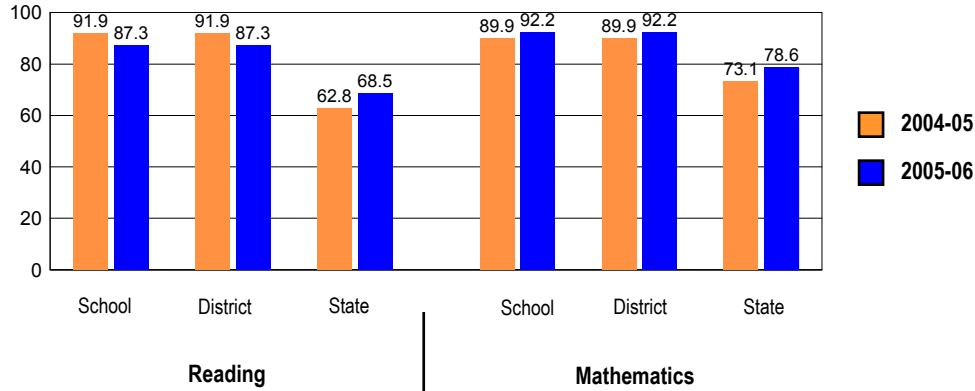

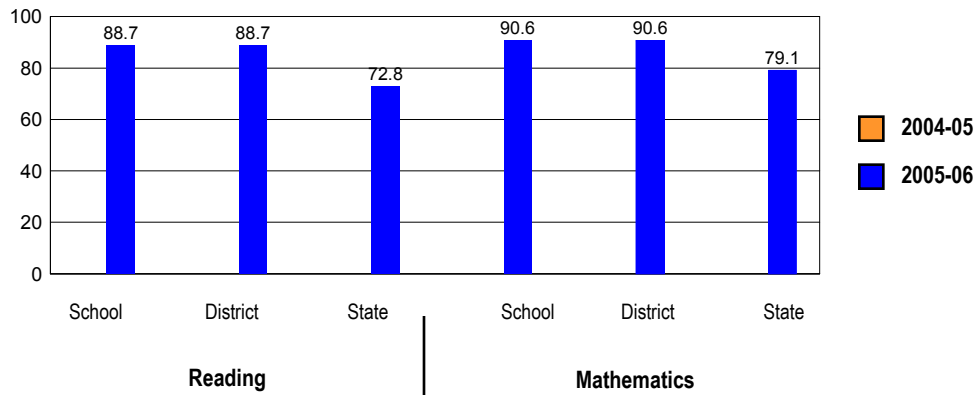
These charts provide information on attainment of the Illinois Learning Standards. They show the percents of student scores meeting or exceeding Standards for the grades and subjects tested on ISAT.

Data for 2004-05 in reading and mathematics for grades 4, 6, and 7 are not available because testing in these subjects for these grades began in 2005-06.

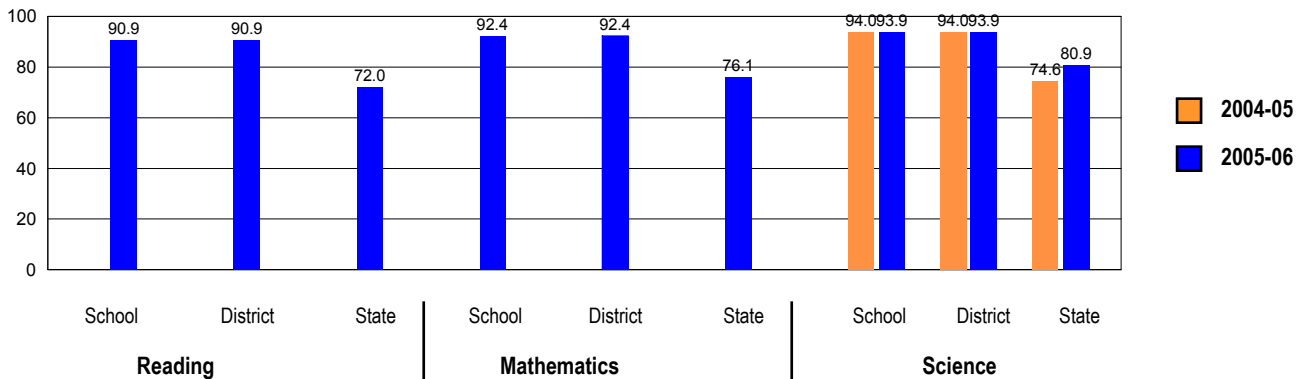
ISAT Grade 5

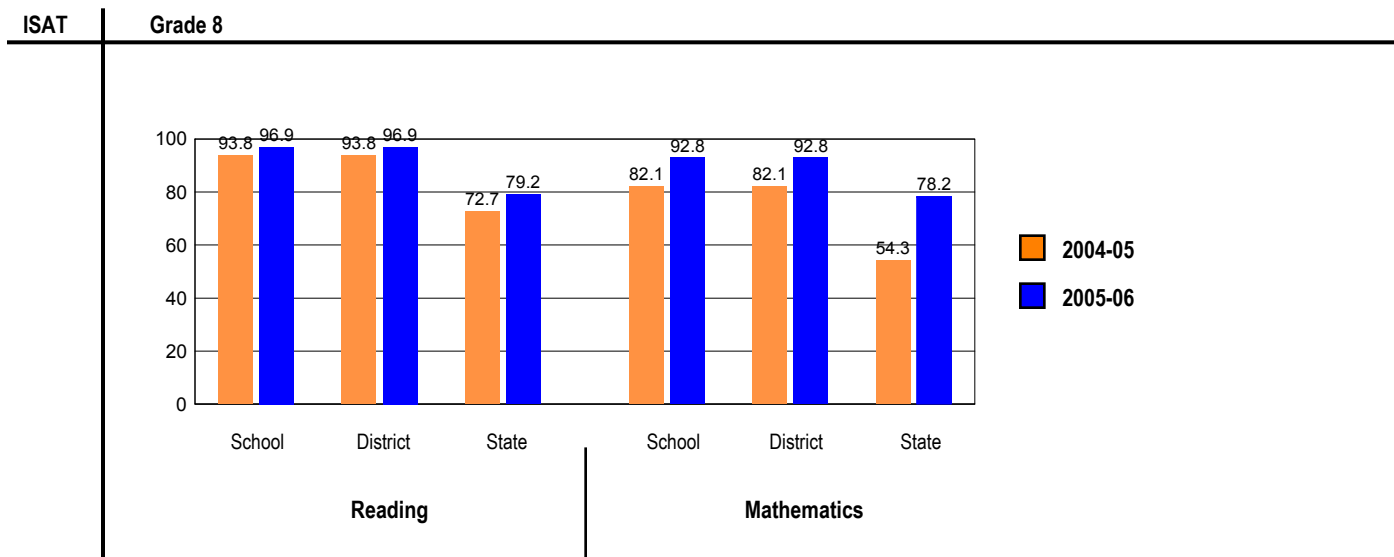


ISAT Grade 6

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Measure of Annual Growth in English (IMAGE) is administered to limited-English-proficient students. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Schools with grade 2 as the highest grade in the school use a state-adopted test in reading and mathematics to meet this requirement.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

The four conditions for making Adequate Yearly Progress (AYP) are:

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 47.5% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 47.5% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. For schools not making AYP solely because the IEP group fails to have 47.5% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 89% attendance rate for non-high schools and at least 69% graduation rate for high schools.

** Safe Harbor Targets of 47.5% or above are not printed.

*** Subgroups with fewer than 45 students are not reported. Safe Harbor only applies to subgroups of 45 or more. In order for Safe Harbor to apply, a subgroup must decrease by 10% the percentage of scores that did not meet state standards from the previous year plus meet the other indicators (attendance rate for non-high schools and graduation rate for high schools) for the subgroup. For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

Gower Middle School Improvement Plan

Students at Gower Middle School continue to demonstrate high achievement on the Illinois Standards Achievement Tests (ISAT). Overall, 92.2% of the students in Gower School District 62 meet or exceed the Illinois Learning Standards.

Gower students benefit from a strong instructional program anchored by a highly qualified teaching staff. More than 64% of the teachers hold advanced degrees in education.

As a school district, Gower is committed to self-examination and continuous improvement. Current district level initiatives are focused on updating and expanding our use of technology for learning and productivity, differentiation, reviewing curriculum in the areas of math and reading, implementation of an induction and mentoring program for new teachers, and building strong collaborative relationships throughout the organization.

At Gower Middle School, the School Leadership Team (SLT) was formed to direct school improvement planning throughout the school year. Based on data gathered during the 2005-06 school year, the SLT developed one academic and one cultural goal for the 2006-07 school year.

Academic Goal: Students will increase academic achievement in reading as measured by the ISAT. Our goal is to have all students score in the meets or exceeds category on the ISAT Reading test. To do this we will:

- Increase by 10% over the previous year the percent of students who score in the exceeds category.
- Decrease by 10% over the previous year the percent of students who score in the below category.

Culture Goal: Celebrate successes and continually improve in the following ways:

- Increase communication and sharing of successes to the broader community.
- Continue to build a positive climate.

The School Leadership Team provides leadership as the Gower Middle faculty implements these goals. Multiple data sources are used to monitor our progress, including standardized test data, online weekly progress reports (Edline), student report cards, ISAT results, Measures of Academic Progress (MAP) data, discipline data, spirit and recognition events, and survey data.

Although students perform well in Gower School District 62 on a variety of measurements, the Board of Education, administration, teachers, staff, parents, and community are committed to helping every child find success.
